## "Multi-Faceted Anti-Corruption Promotion" Project Awareness Raising Seminar

An awareness raising seminar in the framework of the EU funded "Multi-Faceted Anti-Corruption Promotion" project was held on 5 March, 2014 in Vanadzor.

"We are very glad to have the honor to present this grant to the Armenian Young lawyers Association and we hope that it will have a big influence in the fight against corruption", said the Deputy Head of Cooperation of the Delegation of the European Union to Armenia, Mr Jose Maria Medina Navarro

In the words of the Project Manager Karen Zadoyan, the fight against corruption in Armenia has reached a rather important stage. "Today it is necessary to join the efforts of the authorities and civil society organizations in order to be able to fight the corruption and bring it to end," Karen Zadoyan said.

The project aims to increase the role of Civil Society Organizations (CSOs) in promoting anti-corruption reforms and their implementation. In the framework of the project, CSOs and the media will build their capacity to engage in monitoring and watchdog activities. Anti-corruption training will be organized throughout Armenia with the purpose of enabling CSOs and media organizations to better comprehend the issues related to anti-corruption and freedom of information. These activities aim at deepening the existing opportunities of carrying out anti-corruption activities. Small grants will be given for raising the effectiveness of public monitoring and implementation of appropriate monitoring, watchdog and investigative activities. A sustainable dialogue between CSOs and the Government will be developed with the participation of CSOs, to strengthen the anti-corruption institutional mechanisms.

In the framework of the event the Project Manager, Karen Zadoyan introduced the project. Representatives of CSOs and media from Lori and Tavush marzes of the RA participated in the event.

The project is funded by the European Union and implemented by the "Armenian Young Lawyers Association" NGO – Applicant and "Freedom of Information Center" NGO – Partner. The project duration is 3 years (January 2014 – December 2016) and the budget is 650.000 EUR.

**Armenian Young Lawyers Association** (AYLA) was established in1995 with a Mission to promote to the establishment of the rule of law, democracy and formation of the civil society in Armenia, where the people are aware of their rights and their rights are protected.

**Freedom of Information Center** (FOI) operates over 10 years. The Mission of FOI is to promote application of the RA Freedom of Information Law, contribute to the transparency and openness of the Armenian government system and to stimulate civic society's involvement in the governance system.
