“Multi-Faceted Anti-Corruption Promotion” Project Awareness Raising Seminar

An awareness raising seminar in the framework of the EU funded “Multi-Faceted Anti-Corruption Promotion” project will be held on 24 March 2014 at 14:00 in Yerevan, “Best Western Congress Hotel”, “Picasso” hall.

The Project Manager and President of the Armenian Young Lawyers Association NGO, Karen Zadoyan, Representative of the Delegation of the European Union to Armenia, Dagna Lewandowska and the President of the “Freedom of Information Center of Armenia” NGO, partner of “Multi-Faceted Anti-Corruption Promotion” project, Shushan Doydoyan will make welcoming speeches.

Later on, the Project Manager, Karen Zadoyan will introduce the “Multi-Faceted Anti-Corruption Promotion” project, its objectives and directions.

The project aims to increase the role of the Civil Society Organizations (CSOs) in promoting anti-corruption reforms and their implementation. In the framework of the project the capacity of CSOs and the media to engage in monitoring and watchdog activities will be built. Anti-corruption training workshops will be organized throughout Armenia with the purpose of enabling CSOs and media organisations to better comprehend the issues related to anti-corruption and freedom of information. These activities aim at deepening the existing opportunities for carrying out anti-corruption activities. Small grants will be given for raising the effectiveness of public monitoring and implementation of appropriate monitoring, watchdog and investigative activities. A sustainable dialogue between CSOs and the Government will be developed with the participation of CSOs, to strengthen the anti-corruption institutional mechanisms.

Representatives of CSOs and the media will participate in the event.

The project is funded by the European Union and implemented by the “Armenian Young Lawyers Association” NGO – Applicant and “Freedom of Information Center” NGO – Partner. The project duration is 3 years (January 2014 – December 2016) and the budget is 650.000 EUR.

Armenian Young Lawyers Association (AYLA) was established in 1995 with a Mission to promote to the establishment of the rule of law, democracy and formation of the civil society in Armenia, where the people are aware of their rights and their rights are protected.

Freedom of Information Center (FOI) operates over 10 years. The Mission of FOI is to promote application of the RA Freedom of Information Law, contribute to the transparency and openness of the Armenian government system and to stimulate civic society's involvement in the governance system.
