### Workshop of Government – Civil Society Anti-Corruption Working Group

**On December 8, 2015, at 10:00**, the “Armenian Young Lawyers Association” NGO and its partners “Freedom of Information Center of Armenia” NGO and the RA Ministry of Justice are organizing workshop of the Government-Civil Society anti-corruption working group, which titled The liability for illicit enrichment in the RA. Working group will be held in **“Urartu” hall, Erebuni Plaza business center (26/1 Vazgen Sargsyan st., Yerevan, Armenia)** in the framework of the “Multi-Faceted Anti-Corruption Promotion” project funded by the EU and co-funded by the OSCE Office in Yerevan.

Representatives of the Delegation of the European Union to Armenia, OSCE Yerevan office, other international organizations, RA Government and other state and local government bodies, CSOs’ Anti-Corruption Coalition, NGOs and Mass Media will participate in the workshop.

The workshop will begin with welcoming remarks of the representative of the Ministry of Justice, representatives of EU Delegation in Armenia and OSCE Yerevan office, the President of the Armenian Young Lawyers` Association, Coordinator of the Secretariat of CSOs’ Anti-Corruption Coalition, “Multi-Faceted Anti-Corruption Promotion” Project Manager Mr. Karen Zadoyan and the President of the Freedom of Information Center, Deputy Manager of the “Multi-Faceted Anti-Corruption Promotion” Project Ms. Liana Doydoyan. Mr. Carl Ulbricht, the International Expert of “Multi-Faceted Anti-Corruption Promotion” Project will introduce the challenges and vision of criminalization of illicit enrichment in Armenia, the provision on illicit enrichment in the draft of the RA new Criminal Code, needs for criminalization of illicit enrichment in Armenia and problems of illicit enrichment will be discussed.

The project aims to increase the role of the Civil Society Organizations (CSOs) in promoting anti-corruption reforms and their implementation. In the framework of the project the capacity of CSOs and the media to engage in monitoring and watchdog activities will be built. Anti-corruption training workshops will be organized throughout Armenia with the purpose of enabling CSOs and media organisations to better comprehend the issues related to anti-corruption and freedom of information. These activities aim at deepening the existing opportunities for carrying out anti-corruption activities. Small grants will be given for raising the effectiveness of public monitoring and implementation of appropriate monitoring, watchdog and investigative activities. A sustainable dialogue between CSOs and the Government will be developed with the participation of CSOs, to strengthen the anti-corruption institutional mechanisms.

The project is co-funded by the European Union and the OSCE Office in Yerevan, and is implemented by the “Armenian Young Lawyers Association” NGO – Applicant and “Freedom of Information Center” NGO – Partner. The project duration is 3 years (January 2014 – December 2016) and the budget is 650.000 EUR, of which 585.000 EUR contributed by the EU and 15.600 EUR contributed by the OSCE Yerevan Office.

**Armenian Young Lawyers Association (AYLA)** was established in 1995 with a Mission to promote to the establishment of the rule of law, democracy and formation of the civil society in Armenia, where the people are aware of their rights and their rights are protected.

**Freedom of Information Center (FOI)** operates over 10 years. The Mission of FOI is to promote application of the RA Freedom of Information Law, contribute to the transparency and openness of the Armenian government system and to stimulate civic society's involvement in the governance system.
