The Recipients of the Golden Key and Rusty Lock to be announced

The annual "Golden Key and Rusty Lock" award ceremony will take place *on 28 September, 2016, at 11:00-13:00 in Yerevan, Hotel Regineh* (address – Norqi Ayginer 235-1). The ceremony is devoted to the International Right to Know Day and the 15th Anniversary of the Freedom of Information Centre.

The Golden Keys awards will be awarded as a symbol of openness and transparency, and the Rusty Lock awards will be awarded as a symbol of secrecy.

The nominees are selected by an Independent Jury represented by local and international organisations' members, journalists, and scientists in the field. The Jury sums up the results of the monitoring conducted by the Freedom of Information Centre of Armenia (FOICA) and their own experience. Another source for unbiased decision-making is the monthly black list of those officials and institutions which infringed people's right to access to information (quarterly composed by the Freedom of Information Centre). Since 2002 more than 100 countries celebrated 28 September as the International Right to Know Day. In Armenia since 2003 after the adoption of the Armenian Freedom of Information Law the FOICA jointly with its partner NGOs, has initiated the FOI Annual Award Ceremony which become an important awareness raising campaign tool and a stimulus for developing good access to information practices by public bodies.

The Award Ceremony is organised by the Freedom of information Centre of Armenia NGO in cooperation with the Armenian Lawyers' Association by the European Union financial assistance in the frames of Multi-Faceted Anti-Corruption Promotion Project. The event is co-funded by the OSCE Office in Yerevan.

The project is funded by the European Union and implemented by the "Armenian Lawyers' Association" NGO in partnership with the "Freedom of Information Centre" NGO. The project duration is 3 years (January 2014 – December 2016) and the budget is 650.000 EUR.
