## of the "Corruption Risks in Customs Sphere" Anti-Corruption Event

On 25 May, 2016, the Armenian Lawyers' Association (formerly "Armenian Young Lawyers Association" NGO), in cooperation with the CSO Anti-Corruption Coalition, is organising an anti-corruption event dedicated to the state revenue sector in Armenia and entitled "Corruption Risks in Customs Sphere". The event will be held in "Arax" hotel in Gyumri.

The event is organised in the scope of the "Multi-Faceted Anti-Corruption Promotion" Project funded by the EU and co-funded by the OSCE Yerevan Office.

Representatives of the Delegation of the European Union to Armenia, the OSCE Office in Yerevan and other international organisations, the State Revenues Committee and other state bodies, the governing bodies of Shirak region, civil society organisations, mass media, and the Armenian Lawyers' Association, as well as the experts of the "Multi-Faceted Anti-Corruption Promotion" project will participate in the event.

Mr. Hovsep Simonyan, the Governor of the Shirak region, will give a welcoming speech at the event in Gyumri. In addition, Deputy Minister of Justice Mr. Suren Krmoyan, representatives of the Delegation of the European Union to Armenia, the OSCE Office in Yerevan, the State Revenues Committee, and Mr. Karen Zadoyan, the President of the Armenian Lawyers' Association, the Coordinator of the Secretariat of the CSO Anti-Corruption Coalition, will give welcoming speeches. The latter will be followed by reports on corruption risks in customs sphere, challenges of overcoming them and opportunities for cooperation with CSOs in this sphere.

The project aims to increase the role of the Civil Society Organisations (CSOs) in promoting anti-corruption reforms and their implementation. In the framework of the project the capacity of CSOs and the media to engage in monitoring and watchdog activities will be built. Anti-corruption training workshops will be organised throughout Armenia with the purpose of enabling CSOs and media organisations to better comprehend the issues related to anti-corruption and freedom of information. These activities aim at deepening the existing opportunities for carrying out anti-corruption activities. Small grants will be given for raising the effectiveness of public monitoring and implementation of appropriate monitoring, watchdog and investigative activities. A sustainable dialogue between CSOs and the Government will be developed with the participation of CSOs, to strengthen the anti-corruption institutional mechanisms.

The project is funded by the European Union and co-funded by the OSCE Office in Yerevan. It is implemented by the "Armenian Lawyers' Association" NGO – Applicant and "Freedom of Information Center" NGO – Partner. The project duration is 3 years (January 2014 – December 2016) and the budget is 650,000 EUR, of which 585,000 EUR was contributed by the EU and 31,117 EUR was contributed by the OSCE Office in Yerevan.

**Armenian Lawyers' Association** (ALA) was established in 1995 with a Mission to promote to the establishment of the rule of law, democracy and formation of the civil society in Armenia, where the people are aware of their rights and where their rights are protected. Before February 2016, ALA was called Armenian Young Lawyers Association.

**Freedom of Information Center** (FOI) operates over 10 years. The Mission of FOI is to promote application of the RA Freedom of Information Law, contribute to the transparency and openness of the Armenian government system and to stimulate civic society's involvement in the governance system.
